

Bedker Memorial Complex and Cultural Arts Center Carpet Replacement (Submission deadline is 12:00 p.m. on Nov. 9, 2020)

Colby Community College (CCC) is currently seeking competitive sealed bids to replace the flooring in Bedker Memorial Complex and the Cultural Arts Center. The selected vendor would be responsible for the purchase and installation of carpet squares, cove base, and VCT tile, where applicable (Vendor responsibility). The entire area will be pre-prepped for flooring installation (CCC responsibility).

Overview: The carpet (Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) replacement will include the following areas of the Bedker Memorial Complex: 702 Grant, 704 Hodgeman, 705 Meade, 706 Martin, 707 Rawlins, 708 Russel will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (all aforementioned areas require a gray transition strip in the doorway). In the Cultural Arts Center: the entire hallway, Room 301, 302, 303, 304, 305, Band Director's Office, Music Instructor/ Piano Accompanist's Office, and the Vocal Director's Office (all aforementioned areas require a gray transition strip in the doorway). The male and female restroom will receive new VCT tile flooring.

Bedker Memorial Complex:

702 Grant: will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

704 *Hodgeman:* will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

705 *Meade:* will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

706 Martin: will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

707 *Rawlins:* will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

708 *Russel:* will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

Cultural Arts Center:

Hallway Area: will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

Room 301: will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

Room 302: will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

Room 303: will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

Music Instructor/ Piano Accompanist's Office: will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

Vocal Director's Office: will include a carpet replacement utilizing Shaw Carbon Copy Carpet Squares-Color Sidekick, 28 OZ) and cove base (#49 grey) for the entire area (requires transition strip at doorway-gray).

Men's and Women's Restroom: will include a VCT tile overlaw and cove base (#49 grey) for the entire area

Project Timeline: Every area must be completed on or before January 12, 2021. The selected vendor(s) will establish a time frame for replacement with the Seth Carter.

Exclusions: Any project exclusions or any portion of the bid that cannot be completed must be disclosed in an area labeled *exclusions*.

Sales Tax: Colby Community College is a tax exempt entity and all sealed bids should reflect the exclusion of sales tax.

Vendors are <u>required to physically look at and measure the project site</u>. The physical inspection must occur on or before November 6, 2020. All sealed bids need to be finalized and turned in by November 9, 2020, by 12:00 PM (noon) to Thomas Hall (CCC's Main Campus), attention: Seth Carter.

The Board meeting will be held on November 16, 2020, to select a vendor or vendors. The selected vendor(s) will be notified after approval has been received from the Board of Trustees.
