

## **Contactless Water Fountains**

(Submission deadline is noon on Sept. 14, 2020)

Colby Community College (CCC) is seeking competitive sealed bids to purchase <u>30</u> contactless water fountains for the College's campus. The purpose of this bid to provide a safe, hygienic manner for CCC students to utilize water fountains.

### **Vendor Responsibility:**

The selected vendor will be responsible for providing a sealed bid to Colby Community College for 30 contactless water fountains. Water fountains must meet the criteria specified below.

# **Contactless Water Fountain Criteria (Minimum Specifications):**

- Must be an ADA compliant model
- Built in filter
- Minimum of 3,000 gallon filter certified for NSF 42 and 53 for lead, Class 1 particulate, chlorine, taste, and odor reduction
- Touchless, sensor activation model for bottle refills
- Manual push is permitted for fountain bubbler
- Fill rate at minimum of 1.1 GPM
- Visual monitor with LED filter status
- Antimicrobial surfaces
- Digital tracker for the number of 20 oz bottles saved
- Antimicrobial protection on key plastic components to inhibit the growth of mold and mildew
- Real drain system that eliminates standing water
- Rated for indoor use

### **Project Timeline:**

This project will begin on August 20, 2020. Purchased water fountains must be physical delivered to Colby Community's College facility on or before October 12, 2020. Bids that cannot be completed in this time frame will not be considered.

### **Exclusions:**

Any project exclusions or any portion of the bid that cannot be completed as specified must be disclosed in an area labeled exclusions.

#### Sales Tax:

Colby Community College is a tax-exempt entity and all sealed bids should reflect the exclusion of sales tax.

#### **Due Date:**

All sealed bids need to be finalized and turned in by September 14, 2020, by 12:00 PM (noon) to Thomas Hall (CCC's Main Campus), attention: Seth Carter. In addition, due to the nature of these bids, they may be sent electronically, but will not be opened until September 14, 2020 after 12:00 pm.

## **Date of Selection:**

The Board meeting will be held on September 21, 2020 to select a vendor. The selected vendor will be notified after approval has been received from the Board of Trustees.

The bidder to whom the award is made may be required to enter into a written contract with the college and provide a performance or public works bond as required by law or the Board of Trustees (where applicable).
